- ❖ Every application for an Annual Practising Certificate shall be accompanied by proof that the applicant has secured five units of Continuing Professional Development during the previous practice year out of which two units must be from programmes conducted by the LSK CPD committee.
- ❖ This Calendar does not include Courses offered by independent accredited CPD course providers.
- ❖ CPD Charges are KES 4,500 for a one-day seminar and KES 8,000 for a two-day seminar. Advocates of 0-3 years in practice will pay KES. 3,500 for a one-day seminar and KES 6,500 for a two-day seminar unless advised otherwise.
- ❖ The Induction Course shall be compulsory for all newly admitted Advocates. All newly admitted Advocates shall be required to attend at least one Induction Course during their first year of admission at a subsidized cost of KES 1,500.
- ❖ The deadline for booking and payment of CPD events (seminars and webinars) shall be at midnight prior to the seminar/webinar date.
- ❖ Requests for **Cancellation** or transfer of payments must be made in writing (e-mail or letter) and reach LSK office at least 24 hours prior to the date of the seminar. The amount paid is non-refundable but the funds can only be transferred to any upcoming event of the member's choice within the calendar year.
